Message from the Executive Director

With the arrival of summer fire districts can depend on two things for certain:

1) Wildfires, to which we'll be tasked with protecting Arizona's citizens, their property and the state's natural resources (there's a large wildfire burning again in Yarnell as of this writing). This year we've made significant strides to ease the financial burden fire districts have carried. First and foremost, the State Forester has

cleared a majority of the backlog in federal fire payments owed to Arizona fire agencies...from last fire season (thank you Jeff Whitney!), and we gained an essential tool at the legislature for addressing future federal fire contract payment backlogs with the State using Budget Stabilization Funds for "prompt pay" purposes (S1244); AND

 Implementing new laws and regulatory requirements passed by the Legislature each winter (new enactments become effective August 6, 2016 unless enacted with the emergency clause).

There are a number of new laws passed during the recent legislative session that will impact fire districts. Of immediate significance for fire districts is:

S1244: FIRE DISTRICTS; WILDLAND FIRES; BUDGETS (AFDA / PFFA / AFCA Position: SUPPORT) Recent Action: Signed by the Governor with the emergency clause (5/12) – Chapter 219, Laws 2016. Link to Chaptered version: Click Here

S1244 has three (3) main component parts:

- 1. Wildfire "prompt pay" provisions.
- 2. Merger / consolidation fire district assistance tax (FDAT) cap adjustment.
- 3. Voter authorized tax rate cap override (Please note timelines).

Wildfire "Prompt Pay"

Authorizes the State forester to certify claims for federal reimbursement of wildfire suppression costs to the State Treasurer who will pay federal fire claims from the State's budget stabilization fund.

Process Points

- Requires fire agencies to submit a "complete and correct" claim for reimbursement
- Thirty day waiting period for federal government to pay claim

 Payment for fire suppression services to be paid under a certified claim includes "personnel hours, used supplies and reasonable and negotiated costs of damage to equipment that exceeds normal wear and tear"

AFDA Guidance: Ensuring complete and accurate state cooperator billing documents that can be "certified" by the State Forester will be essential to facilitating timely payment of claims.

Fire agencies currently owed contract reimbursement for federal fires should contact the State Forester for funding through the budget stabilization fund.

Merger / Consolidation FDAT Cap Adjustment

Authorizes fire districts which merge or consolidate to combine FDAT to establish a new "maximum cap" amount based upon a formula which averages the preceding five years of FDAT for each affected fire district in a merger or consolidation, then combines the five-year average amounts to establish a new "maximum cap" notwithstanding the current \$400K annual maximum for fire districts.

The merger / consolidation FDAT cap adjustment is retroactive to those fire districts which merged or consolidated with an effective date of July 1, 2014 or thereafter.

Process Points

- New FDAT levy cap based upon sum of the average consolidating districts received for the five fiscal years preceding the merger or consolidation
- In FDAT tax rate cap counties: Allows merged or consolidated districts to adjust FDAT cap revenue once county values recover sufficiently to tax with an FDAT rate below .10
- Pro-rata share amount remains applicable to merged or consolidated fire districts in counties at the .10 FDAT tax rate cap limit

AFDA Guidance: Fire districts should verify FDAT calculations being made by respective County Treasurer to ensure accurate accounting of FDAT distribution.

Voter Tax Rate Cap Override

Authorizes fire district governing boards to place a question before the voters in the next two general elections (November 2016 or November 2017) whether to allow the district to temporarily override the 3.25 tax cap to a maximum of 3.50 for a period not to exceed five fiscal years following the ballot approval.

Process Points

Deadlines for fire districts seeking a voter approved tax rate cap override for beginning in fiscal year 2018 (July 1, 2017 implementation) are quickly approaching. Fire districts should contact their respective county elections department for county specific guidance. Non-statutory deadlines may exist and are county specific (e.g. Maricopa County requires an additional IGA for ballot measures with a mid-June deadline).

- Limited to next two general elections NOTE: Short timeline for inclusion on the November 2016 general election ballot.
 - * 120 Day Notice Deadline by law July 11, 2016
 - * 105 Day Ballot Text Deadline July 26, 2016
- Temporary measure (session law) with limited effective date for implementation
- Fire district reverts to 3.25 tax rate cap at end of five-year override period

AFDA Guidance: Fire districts should seek legal / professional guidance for implementation as necessary. Timeline is critical for those districts seeking to be on the November 2016 ballot.

Our advocacy efforts this past session were carried out in partnership with the Professional Fire Fighters of Arizona (PFFA) and the Arizona Fire Chiefs Association (AFCA). A continued commitment by AFDA, PFFA and AFCA to work as a single unified voice of the Arizona fire service is essential if we expect to continue the success we enjoyed this past session.

I've listed additional bills passed during the recent legislative session which fire districts should be mindful of. Detail and guidance for implementing these new laws will be provided at the AFDA Conference in July.

- \$1428: PSPRS MODIFICATIONS (PFFA / AFDA Position: SUPPORT) Recent Action: Signed by the Governor (2/16) – Chapter 2, Laws 2016. Link to Chaptered version: Click Here

- H2197: FIRE DISTRICTS; MERGER; CONSOLIDATION (AFDA / PFFA Position: SUPPORT) Recent Action: Signed by the Governor (5/11) – Chapter 183, Laws 2016. Link to Chaptered version: Click Here (NOTE: H2197 language is mirrored in S1244 and therefore is effective May 12, 2016).
- H2198: FIRE DISTRICTS; VACANCIES; BOARD OPERATIONS (AFDA / PFFA Position: SUPPORT) Recent Action: Signed by the Governor (4/5) – Chapter 97, Laws 2016. Link to Chaptered version: Click Here
- S1137: CPR; SCHOOLS (AFDA / PFFA / AFCA Position: SUPPORT) Recent Action: Signed by the Governor (5/12) – Chapter 216, Laws 2016. Link to Chaptered version: Click Here
- H2350: PUBLIC SAFETY EMPLOYEES; COUNSELING (PFFA / AFDA position: SUPPORT) Recent Action: Signed by the Governor (5/12) – Chapter 240, Laws 2016. Link to Chaptered version: Click Here

Capstone Internship Project

In hopes of clearing up many common misconceptions regarding calling into the 911 system, Valley Emergency Communications Center (VECC) and Drexel Heights Fire District (DHFD) wanted to do something. Together they submitted a Capstone Internship Project through the University of Arizona.

Each year, University of Arizona School of Government and Public Policy, Masters of Public Administration candidates participate in this Capstone Internship Project. Projects are submitted by local non-profits and government entities. The professor selects the top ten worthy projects. Class candidates then sign up for and work on transforming the projects into a reality. VECC and DHFD's submittal, based on a public service announcement campaign which would educate the public on what to expect when calling 911, was selected.

The results were a media packet which included video, radio and print materials which were distributed. The dedication of these Capstone Candidates seeing the project mission thru was exceptional. The feedback on the quality of the finished materials was tremendously encouraging. Not only did the media pick up and run the PSA, but many Arizona fire agencies shared the PSA on their websites and social media. Treat & Refer Update

E MS providers routinely encounter patients who need the social or health services offered in their community, but because EMS was created and organized around the transport of patients to an emergency department, they have not been able to meet that need. That may be about to change.

Last year, EMS providers approached the Arizona Health Care Cost Containment System (AHCCCS) to review the potential benefits to AHCCCS clients if the EMS organization implemented a Treat and Refer program. Soon afterwards, AHCCCS and the Arizona Department of Health Services (ADHS) met to identify how an initiative like this could be supported and organized and the Treat and Refer Steering Committee was born.

Invitations were sent to the Arizona Fire Chiefs Association, Arizona Fire Districts Association, Arizona Ambulance Association, and the Arizona Chapter of the American College of Emergency Physicians asking for representatives to participate in the development of the treat and refer manual. Other content experts were also asked to participate.

The first of three planned discussion and development meetings was hosted at the Phoenix Fire Training Center in December 2015. Attendees rotated through four discussion workgroups: Education, Medical Oversight, Data Collection, and Recognition. The output of this meeting December was a set of writing tasks for each of the four workgroups. Two subsequent meetings were held on February 23 and May 6, when the final draft was presented to the Treat and Refer Steering Committee for comments.

The next stop for the document is the EMS Council and Medical Direction Commission, where members will be asked to review and approve the document during the May 19, 2016, meetings. For further information, please contact David Harden at hardend@azdhs.gov or 602-364-3188.

Reflection on My Career - July 26, 1976 to July 24, 2016

n July 22, 2016 Fry Fire Chief Bill Miller will be retiring with 40-years of service and 15-years on the board of AFDA.

Family first, community, and then the job, sometimes it was quite the opposite.

I thank the many friendships that were formed through work and outside of work. Those relationships I will continue to appreciate long after my retirement. I thank my wife for taking care of me, putting our family first in her life, and making sure that my outfits matched. She's the rock of our family and the rock that I felt against my head a many times for disagreeing with her. I thank my daughter Samantha and my son Sean for always being there for me and supporting me when I needed them. I thank them for being my friend and making me proud every day for the things they now do for their communities. Samantha is a school teacher and Sean is a Deputy Sheriff.

I thank all those working relationship within the City of Sierra Vista management, the Sierra Vista, Palominas, Fort Huachuca Fire Departments, CCSO, SVPD and the many other Fire and EMS agencies in Cochise County and Arizona. I also want to express my appreciation to all the current and past Fry Fire District Board members, Fire Chiefs and employees who have served with pride, respect, integrity, dedication, and honor. They have been very supportive of me during my career.

During my career I have seen the expansion of fire district was ervices; Ambulance service, EMT's and Paramedics, Hazardous Materials Team, Tactical Rescue Team, SWAT team medics, out of State Wildland assignments, Ambulance billing services, a fleet maintenance program, annual employee recognition and awards, additional personnel, newer apparatus and remodeled fire stations.

Some of my most memorable calls:

- The death of a fellow Firefighter "David Deary" April 28, 1979
 while trying to rescue two teenagers off the Carr Canyon
 Falls.
- Miracle Valley Shootout early 1982, I still remember all the tension in the community and in the Sheriff's Department. All the Firefighters wanted to carry weapons for our own protection, but we didn't. We always had the Sheriff Officers by our sides.
- The old barracks fire on Fort Huachuca July 5, 1987 (23-buildings totally involved with fire). I remember filming part of the fire with my old VHS tape recorder and the amount of fire and heat was just unbearable.
- November 12, 1990 a 9-year old boy name Justin Steiner jump off his grandparent's roof and accidental fell onto a steel rod that had pierced his heart and jugular vein while still

- being impelled until we were able to cut it off at the ground level. We transported him to the hospital where he survived! This incident made national headlines. God was with him and us on that day.
- Multi-vehicle accident October 2004 on Hwy 90 and the East gate that resulting in 6-deaths.
- Monument Fire June 2011, the largest most complex fire I have ever dealt with during my entire career. The community lost over 72-structures and several thousand acres of wildland. But we didn't lose any lives and we had no major injuries. We also saved several hundred homes from the fire. I can express how proud I am of all the Firefighters and Police Officers that maintained their professionalism during this fire. The Monument fire affected every community member in one way or another, but I am also very proud of our community members and businesses that came together not only for the emergency workers but for all the families that lost homes or businesses.

What I enjoyed:

- Taking emergency calls. I really enjoy taking calls and being a part of a team of professions that help individuals in their time of need. This was not a job but an exciting and caring professional career.
- Keeping our taxing rate as low as possible while providing exceptional service to the community which at times has been difficult
- Mv administrative team in the office
- Receiving over \$2.7 million dollars in grants over the last 12vears
- Increased our capital reserve fund from just under \$300K to just over 1.2 million dollars and we have also started a leave reserve fund during my time as Fire Chief
- Creating no fire district DEBT, our citizens own everything free and clear
- Employees, each one of them I have learned from, both the bad and good
- Working with the City of Sierra Vista to create an emergency response plan that has no boundaries when dealing with someone's emergency (closest unit response) that has saved several lives and homes.
- Committees I have served on; Cochise County Emergency Medical Council-Chairman, Southern Arizona Emergency



Medical Council Vice Chairman, Arizona Fire District
Association Board serving Cochise, Graham, Santa Cruz and
Greenlee counties, Canyon Vista Medical Center Board of
Trustees-Vice Chairman, Cochise County Building Code
Advisory Board-Vice Chairman, Arizona Ambulance
Association and past President of the Sierra Vista Rotary
club.

Working with the many non-profit community organizations in the area that help so many people in Cochise County.
My plans now will be focused on my two granddaughters Charlee who is three years old and Loucee who is 1, my wife Patti, daughter Samantha and Son Sean, and of course getting in a few more rounds of golf. We be moving to the Queen Creek area in August of this year.

What I won't miss:

Budget restraints, employee problems and listening to the fire radio every night. During my career I have seen us go from 1 or 2 calls a week to over 25 calls a day.

Also back in 2005 when I was promoted to Fire Chief I also promote myself to the head janitor job by coming in on weekends to clean the offices, classroom, and bathrooms. That I surely won't miss, but that was my promise I made to the guys so they all could get raises by all of us doing more around the stations to save money anywhere we could and that would be my contribution for them to receive a pay raise.

Unfortunately I have seen many calls involving multiple deaths caused by fires in our community and the deaths caused by serious injuries or accidents. Those are the things I'd like to forget about. I have seen families that have lost loved ones, loss property due to fires, and damage from high winds and flooding. I have also seen the good in families and our communities come together for others in their time of need during emergencies. I'll be forever grateful for to all those who have help others. I've been very blessed and I am very grateful to my family and community. I can't begin to express the gratitude and respect I have for serving our community for the past 40-years.

Consolidation of Clarkdale & Verde Valley Fire Districts

With the direction from the Board of Directors from both Clarkdale Fire District (CLFD) and Verde Valley Fire District (VVFD), Fire Chief Joe Moore and Fire Chief Nazih Hazime have been working with staff and to evaluate the operational and financial aspects of both Fire Districts. A preliminary report appeared to be favorable and allows us to move forward into a feasibility study. This directive from the Board Members followed a resolution from CLFD Fire Board requesting VVFD's Fire Board to consider consolidating with CLFD. The VVFD Fire Board adopted a resolution considering a consolidation with CLFD. This was the first step of many to follow based on the Arizona Revised Statutes §48-822 which revealed consolidating will enhance service efficiency and increase cost savings through identifying redundancy within both Fire Districts. This study process encompasses all areas of the fire districts which exposed areas for improvement. The process resolved with both Fire Boards unanimously passing the resolutions to consolidate the Districts. Effective July 1, 2016 Clarkdale Fire District will dissolve and be absorbed by Verde Valley Fire District. This will increase the VVFD to 104 square miles and serve 21,300 residents. Almost everything was in line with both fire district including the Mil Rates which help streamline the 11 month process. Both fire districts are very excited to come together for the betterment of the community we serve.




