**Seasonal Wildland Engine Boss**- This position would fill an opening on an apparatus when resourced out and be paid by VFD. **The wage is \$25.00 PER HOUR. Plus Overtime when on assignment. \*This is an on-call position not a staffed position.**

Minimum requirements for this position are:

- Be at least 20 years of age and possess a valid AZ Driver's License with acceptable driving record for the past 3 years.
- Must provide certificates of training and provide verifying of Engine Boss certification.
- Must be able to pass a pack test to be red card certified for Vernon Fire District
- Or a valid "Red Card" issued by your home agency with current RT-130 Refresher Cert.
- Be able to pass a drug test, and a background check.
- Ability to commit to 18-21 days with little to no notice
- Possess all necessary personal items for a "3 week bag", etc. for extended assignment
- You must be able to follow directions and be physically fit to perform the required duties.
