



## AVRA VALLEY FIRE DISTRICT Establishment of an Eligibility List for Full-Time Employment

**Full-Time Firefighter/EMT Starting Pay: approximately \$46,200/Yr**  
**Full-Time Firefighter/Paramedic Starting Pay: approximately \$54,600/yr**

**Applications are being accepted until 1/31/24**

The Avra Valley Fire District is currently accepting applications to hire full-time firefighters. If you are interested, email your application, and all supporting documentation, to [rklein@avfire.org](mailto:rklein@avfire.org). Applications will only be accepted by email. You will need to provide copies of documents that verify you meet all of the minimum qualifications listed below in **bold print** with your employment application. Applications that do not contain proof that a candidate meets the minimum qualifications will be rejected. The only exception is for individuals currently in a fire academy, please see application for details.

### ***CRITERIA THAT MAY BE USED IN ESTABLISHING THE ELIGIBILITY LIST:***

- Review of application and supporting documents
- Written exam
- Practical exam
- Physical agility test
- Panel oral interview
- Chief's interview

**NOTE: Preference points will be awarded for military service if a valid DD form 214 is submitted with the candidate's application.**

The firefighter works under the supervision of a fire captain or his/her assigned representative. The firefighter responds to alarms and protects life and property by performing firefighting, emergency medicine, hazard control and other duties as assigned. The firefighter also maintains fire and emergency medical equipment, apparatus, and facilities. **(SEE POSTED JOB DESCRIPTIONS)**

### ***MINIMUM QUALIFICATIONS:***

- **18 years of age or older at time of hire**
- **A valid Arizona driver's license**
- **High school diploma or G.E.D. equivalent**
- Ability to speak, read, and write the English language
- **Arizona Firefighter I and II certification or NFPA 1001 equivalent**
- **Arizona Certified EMT-Basic or Paramedic**
  - **Advanced Cardiac Life Support for paramedic applicants**
  - **Pediatric Advanced Life Support for paramedic applicants**
- **Healthcare Provider level CPR certification**
- **Hazardous Materials First Responder; Operations Level**
- **Basic Wildland Classes S-130, L-180, and S-190**
- Meet AVFD physical standards and the insurability requirements of the District's insurance carrier

- Public Safety Personnel Retirement System retirement plans. Tier2 and Tier3 employees receive employer matching contributions to deferred compensation savings plans
- Medical and dental insurance programs
